
Sub: Allotment of BPL rice for issue under TPDS for the month of August, 2012 (both Central Pool (CP) and State Pool (SP))

In partial modification of this Department Letter No. 10685/FS&CW dt. 4.7.12 on the subject cited above, I am directed to say that the allotment of BPL rice for the month of August, 2012 made against Kalahandi district may be read as 1622.35 MT under C.P. and 2051.8 MT under S.P. respectively instead of 0.0 MT under CP & 3674.15 MT under S.P. Further, the allotment of BPL rice for the month of August, 2012 made against Bargarh district under C.P. & S.P. may be read as 890.33 MT & 2351.42 MT respectively instead of 2512.68 MT under C.P. & 729.07 MT under S.P. as per Annexure-I.
