CONDITIONS

1. If the requirement is less than one rake the applicant should jointly apply for one rake quantity in a quarter along with other eligible applicants.
2. The rake may be distributed to the nominees basing on the overall turnover, overall demand / supply position in the destination area for which rakes are intended. The past track record of nominees in lifting the full quantity of rakes allocated previously (if any) will be taken into consideration.
3. In case any nominee fails to lift quota of previous quarter, his allocation is liable to be cancelled and allocated to other applicants.
4. After receiving the salt rakes from the State of Gujarat and Rajasthan, the salt nominees should ensure supply of iodized salt to the open market for the purpose of sale. Only iodized salt will be brought under the nominee system.
5. The Salt nominees may apply for more than one places according to their preference and unloading points shall be chosen throughout the State covering all parts.
6. Salt nominees shall not exercise their option for loading and unloading destination points. For loading of salt rakes, the nominee shall only mention the name of states from where they shall be willing to lift the rakes i.e., either Rajasthan or Gujarat.
7. Destination points for unloading of salt rakes will be decided by the Govt. for the purpose of wide distribution of iodized non-refined salt throughout the State.

The intending applicants should submit the completed application form in all respects to the Deputy Secretary, F.S. & C.W. Department by speed post or by registered post etc. so as to reach the Department by dt.24.06.2016.
