I am directed to communicate district-wise allotment of 15006.059 MT of rice as per Annexure-'A' out of 227615 MT of additional adhoc allocation of rice meant for additional BPL families for distribution among the flood affected BPL families for ten days more _____ as relief measure as per annexure enclosed. It may be mentioned here that the above quantity of rice ___ now allotted is against the un-lifted quantity of rice as mentioned against each district.

The allotted quantity may be lifted from FCI soon after receipt of this communication. The cost for this quantity has been deposited with FCI centrally by OSCSC. The allotted quantity will be distributed to bonafide flood affected BPL families for 10 days as mentioned in the original letter.

The validity period for lifting of this rice will be up to 31st August, 2012. Copies of such allocation may be made available to Hon'ble M.P / M.L.A and Chairperson of PS for their information. All other terms and conditions enumerated in this Department's earlier letter will remain unchanged.

The relief rice may be distributed by Collectors free of cost as was done on previous occasion during Emergency relief. FPS retailers may not be involved in distribution of this rice meant for BPL families of flood affected persons.

The transportation cost for this rice may be claimed to OSCSC Ltd. for reimbursement.

You are, requested to ensure that the food grains reach the intended beneficiaries without any dislocation.
