With reference to the subject cited above, I am directed to communicate an allotment for a quantity of 16.750 MT of rice for each month of August, 2012 to October, 2012 as per the details below for distribution among the Differently able persons with 75% or more disability identified under the scheme.

Number of beneficiaries – 1675  
Scale of allocation - @ 10 Kg per month per beneficiary.  
Allocation for – 3 months (August, 2012 to October, 2012).  
Allocated quantity – 1675 x 10 Kg. x 3 months = 50.250 MT.

You are requested to lift the rice for this scheme (RDP) from the DCP stock. This rice is being used from the APL rice allocated to the State. Lifting may be done soon after receipt of this allotment order. It may be distributed on regular basis along with other PDS scheme on pre-fixed dates.
