**Sub: State pool allotment of rice for ST & SC Hostel for the month of September, 2016.**

Sir,

I am directed to communicate district wise allotment of 7331.205 MT of rice for S.T. & S.C. Hostels, for the month of September, 2016 as per the quantity mentioned against each in the annexure enclosed. The scale of entitlement will be limited to 15 kg. per inmate per month @ Re.1/- per kg. uniformly. This allotment will be lifted from State pool. The validity period for depositing the cost and lifting of rice will be upto 31.08.2016.

2. You are requested to deposit cost of rice so much in advance soon after receipt of the allotment order and ensure lifting and distribution by 31.08.2016 positively. All other terms and conditions will remain unaltered.

3. This allocation may be distributed only amongst the S.T. & S.C. Hostels as per the list provided by the S.T. & S.C. Development Department on the basis of intake capacity and number of boarders approved by the S.T. & S.C. Development Department.

4. There will be no diversion of rice from other schemes henceforth.

5. Institutions should be given entitlement cards to enable them to draw rice. The officers of concerned Department will certify utilization of stock for bonafide purpose in the card every month.

6. In case, closing stock is available with the institutions, equal quantity will be reduced from the allocation for the next month.




