Sub: Allotment of APL rice at APL rate for each month of November, 2012 to March, 2013 to meet the requirement of prisoners of the jails.

Sir/Madam,

I am directed to communicate an allotment of APL rice under TPDS against Government of India's allocation for distribution. The Government of India has allotted 2593 MT ( 1729 MT Normal + 864 MT additional) of APL rice for each month of November, 2012 to March, 2013. Out of which an allotment of 571 MT of APL rice may be utilized for requirement of jails at APL rate of Rs.9.30 per Kg. for each month of November, 2012 to March, 2013 as per annexure enclosed as per norms fixed by Home Department.

It will be mandatory for these jails to deposite the cost of food grains to CSO-cum-D.M. of their district latest by 15<sup>th</sup> of each allocation month as Odisha is a DCP State.

In case any quantity of rice is not required for jails, it should be utilized for PDS distribution.
