Sub:- Allotment of additional/ adhoc allocation of rice under TPDS for 19 poorest districts-distribution for each month of November, 2012 to October, 2013.

Sir,

With reference to the subject cited above, I am directed to communicate district wise allotment of 15196.225 MT of additional adhoc rice for each month of November, 2012 to October, 2013 meant for poorest districts which may be distributed @ 25 Kg per beneficiary @ Rs.2/- per Kg per month identified under the above scheme as per details in the Annexure enclosed.

The total number of 6,07,849 poorest families in 19 districts may be covered under the scheme.


A quantity of 2.725 MT of rice per month is diverted to Rayagada district for distribution of the same among 109 PLO beneficiaries of Garadama GP of Mohana Block of Gajapati District due to transportation difficulties in Gajapati District.

The total allotted quantity of 182354.7 MT of additional / adhoc rice may be lifted from DCP stock for 12 months (from November, 2012 to October, 2013) by 31st March, 2013 which is the validity period for lifting of the additional / adhoc allocation.

The Collectors are requested to ensure advance lifting of rice to facilitate issue of two months stock at a time in every month, so that by ~~March~~^{April} 2013 stock for 12 months can be issued within the stipulated period.

You are requested to kindly furnish lifting position of additional / adhoc allocation of rice & its distribution every month by the subsequent month positively to this Department without fail.




They are further directed to ensure submission of lifting position of such rice every month by the 5th of subsequent month to this Department without fail.




