**Sub: State pool allotment of BPL rice for SC & ST Hostel for each month of December, 2012 to March, 2013.**

Sir,

In supersession of this Department letter No.18940 dt. 04.12.2012 on the subject cited above, I am directed to communicate district wise allotment of 5288.43 MT of BPL rice for S.T. & S.C. Hostels, for each month of December, 2012 to March, 2013 as per the quantity mentioned against each in the annexure enclosed. The scale of entitlement will be limited to 15 kg. per inmate per month @ Rs.2/- per kg. uniformly. The entire quantity of this allotment will be provided by the OSCSC Ltd. from the State pool.

The validity period for deposit of cost and lifting of food grains from the months of October, 2012 to December, 2012 will be up to 45 days from the date of issue of Government of India letter which was issued on 26.11.2012. The validity period for deposit of cost and lifting of food grains for the subsequent months of January, 2013 to March, 2013 will be as per instant instructions of Government..

2. All other terms and conditions will remain unaltered. This allocation may be distributed only amongst the S.T. & S.C. Hostels as per the list provided by the S.T. & S.C. Development Department on the basis of intake capacity and number of inmates approved by the S.T. & S.C. Development Department.

3. There will be no diversion of rice from other schemes henceforth.

4. Institutions should be given entitlement cards to enable them to draw rice. The officers of concerned Department will certify utilization of stock for bonafide purpose in the card every month.

5. In case, closing stock is available with the institutions, equal quantity will be reduced from the allocation for the next month.


