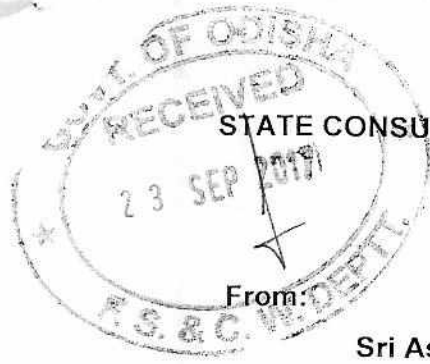

## GENERAL TERMS AND CONDITIONS

1. The interested Bidders may submit their bid application alongwith an Earnest Money Deposit of Rs.5,000/- by way of Demand Draft in favour of Secretary, State Consumer Disputes Redressal Commission, Odisha, Cuttack.
2. The quotations received in time will be opened in this Commission. The Bidders or their representative (not more than one) may be present, if they so desire, at time of opening quotations.
3. The auction will be governed by the following conditions.
  - (i) The successful bidder will be required to deposit the balance bid amount after deducting earnest money of Rs.5,000/- latest within one week of opening of bids by way of Demand Draft in favour of Secretary, State Consumer Disputes Redressal Commission, Odisha, Cuttack.
  - (ii) The delivery of the sold vehicle will be given only after the successful bidder submits documentary evidence in support of residential status, Voter identity Card in case of individual and Registration Certificate in case of firms etc.)
  - (iii) The sold vehicle shall have to be removed by the successful bidder immediately at his own expenses.
