Hon'ble Supreme Court's direction-Allotment of adhoc additional allocation under TPDS for poorest districts- Distribution for each month of January, 2012 to March, 2012.

Sir,

In pursuance to the directions of Hon'ble Supreme Court in its order dt.14.9.2011, I am directed to communicate allotment of 1898.61 MT and 275.94 MT of adhoc additional rice under TPDS per month meant for poorest districts in respect of Nabarangpur and Sambalpur district respectively for distribution @ 35 Kg per beneficiary @ Rs.2/- per Kg. per month identified under the above scheme.

The total number of 54256 and 7884 families of Nabarangpur and Sambalpur districts respectively may be covered in the ratio of 5: 8 for AAY and BPL category under the scheme at your level. The poorest families are to be covered under AAY category and rest under BPL category for record purposes.
