- Each BPL card holder and APL card holders of KBK are entitled to lift 25 kg. of rice

- 10. Moreover, you are requested to reduce the quota according to the number of Ration Cards cancelled during campaign from November, 2010 to December, 2010, at the time of making suballocation to the blocks and ULBs of the districts
