I am directed to communicate district wise allocation of 92252.000 MT of BPL Rice (Both CP & SP) for the month of February, 2013 for distribution under TPDS to the BPL consumers as per Annexure-I.

- Morably allotment of 13384.075 MT BPL rice for the month of February, 2013 is hereby made for distribution under TPDS to the APL consumers in both Rural and Urban areas of KBK districts as per Annexure-II. Out of 2577.325 MT of BPL rice allotted to Kalahandi district 6.75 MT shall be lifted by C.S.O., Rayagada for distribution to the APL families of Gopinathpur, Kerpai, Odri and Maligaon G.P. under Th. Rampur Block of Kalahandi district.
- Out of 3662.65 MT of BPL rice allotted to Kalahandi district, 6 MT shall be lifted by the C.S.O.-cum-D.M., O.S.C.S.C. Ltd., Kandhamal for distribution to the BPL families of Lubengarh village of Urladani G.Ps of M. Rampur Block as they are inaccessible from Kalahandi district.
- Out of allotment of 3662.65 MT BPL rice in favour of Kalahandi district 57.9 MT of rice will be diverted to Rayagada district for distribution to BPL families of Gopinathpur, Kerpai, Odri and Maligaon G.P. under Th. - Out of the allotment of 1425.825 MT of BPL rice in favour of Gajapati district, 11.425 MT will be lifted by C.S.O.-cum-D.M., O.S.C.S.C. Ltd., Rayagada for distribution to the BPL beneficiaries of 12 villages of Gordama G.P. under Mohana block of Gajapati district.
- Other general instructions regarding scale of entitlement, sub-allocations and enforcement measures atc. communicated vide letter No.13657(30) / Food, Supplies and Consumer Welfare Department dated 20.6.2005 shall remain unchanged except consumer price.
- Each BPL card holder and APL card holders of KBK are entitled to lift 25 kg, of rice @ Rs.2/-per Kg.
