I am directed to communicate district wise allotment of 6230.355 MT of BPL rice for S.T. & S.C. Hostels, for the month of April, 2013 as per the quantity mentioned against each in the annexure enclosed. The scale of entitlement will be limited to 15 kg. per inmate per month @ Rs\_1- per kg. uniformly. This allotment will be lifted from own CMR as no allocation of rice under the said scheme for the year 2013-14 has been released by Government of India.

- All other terms and conditions will remain unaltered. This allocation may be distributed only amongst the S.T. & S.C. Hostels as per the list provided by the S.T. & S.C.
