Sub: Allotment of BPL rice for S.T. & S.C. Hostels for each month of April, 2012 to September, 2012 - from out of Central Government allotment.

Sir,

I am directed to communicate district wise allotment of 879.0216 MT of BPL rice for S.T. & S.C. Hostels, for each month of April, 2012 to September, 2012 as per the quantity mentioned against each in the annexure enclosed. The scale of entitlement will be limited to @ 15 kg. per inmate per month @ Rs.2/- per kg. uniformly. This allotment will be lifted from Central Pool stocks of F.C.I. / CMR of DCPS as per the lifting plan of the O.S.C.S.C. Ltd. Rice utilized from own CMR may please be replenished.

- The validity period for deposit of cost and lifting of food grains for the months of April to May, 2012 will be upto 45 days & 50 days respectively from the date of issue of Government of India letter, which was issued on 09.04.2012 and for the subsequent month of June to September, 2012 will be as per normal procedure under TPDS allocation.
- All other terms and conditions remain unaltered. This allocation may be distributed only amongst the S.T. & S.C. Hostels as per the list provided by the S.T. & S.C. Development Department on the basis of intake capacity and number of inmates approved by the S.T. & S.C. Development Department. The rice will be lifted by the Rice Receiving Centre- cum-Departmental Storage Centre immediately and made physically available to the institutions.

The Officer in charge of RRC-DSC will issue cash Memo to the institution and obtain signature.

- There will be no diversion of rice from other schemes henceforth with.
- Institutions should be given entitlement cards to enable them to draw rice. The officers of concerned Department will certify utilization of stock for bonafide purpose in the card every month.
- The institutions will lift their quota from the concerned RRC-cum-DSC. They will not be asked to lift rice from F.C.I. / D.P.C. Depots. The officer in charge with issue cash memo to the institutions and obtain signature.
- In case, closing stock is available with the institutions, equal quantity will be reduced from the allocation for the next month. However, full quota of Central Pool must be lifted by O.S.C.S.C. Ltd., and no quantity should be allowed to lapse.
