Sub: Re-allotment of 32256 M.T levy sugar in favour of Govt. of Odisha against un-delivered stock by the allotted sugar mills as per Govt. of India allotment for Oct'11 to June'12.

Sir,

With reference to the letter on the subject cited above, I am to say that, in order to enable the Govt. of Odisha to lift the allotted levy sugar, the validity period of the levy sugar release orders on the following eight defaulting sugar mills were extended by the Govt. of India vide Order No-5-5 (Odisha)/2012-SC-II/66 dated 14.03.2012 up to 30.04.2012.

2. Out of the above, only three mills namely i) Athani Farmers Sugar Factory Ltd., Code-52004/ Madbhavi, Karnataka, ii) Natural Sugars and Allied Industry Ltd. Code 50701/ Ranjani and iii) Vithal Rao Sindhe SSK Ltd., Code No- 52001/ Pimpalner, Maharashtra have delivered 2460.4 M.T., 2698.5 M.T. and 2596.5 M.T. sugar respectively. In-spite of repeated correspondence and telephonic contact, the following five mills have not delivered the allotted levy sugar for the reasons mentioned against each.

3. Subsequently, against G.O.I allotment for the period from March, 2012 to June, 2012 the following three sugar mills have not delivered the allotted levy sugar for the reasons mentioned against each.

The total un-lifted levy sugar on the above mentioned eight sugar mills comes to 32256 M.T. which constitutes about four months state quota. All these problems were reported to the Directorate of Sugar, Govt. of India vide Letter No. 9153 dated 15.05.2012 and No- 9326 dated 18.05.2012 of the Odisha State Civil Supplies Corporation Ltd. (copy enclosed).

It is therefore requested that re-allotment of 32256 M.T. levy sugar may be released on mills having levy sugar packed in 50 kg jute bags only out of 2011-12 production stock to avoid dislocation in distribution of sugar among targeted beneficiaries.
