
In exercise of the powers conferred by section 3 of the Essential Commodities Act, 1955 (10 of 1955) read with clause 9 of the Targeted Public Distribution System (Control) Order, 2015, the State Government do hereby make the following Order further to amend the Odisha Public Distribution System (Control) Order, 2016, namely:-

1. Short title and commencement. – (1) This Order may be called the Odisha Public Distribution System (Control) Second Amendment Order, 2022.

(2) It shall come into force on the date of its publication in the Odisha Gazette.

2. In the Odisha Public Distribution System (Control) Order, 2016, in clause 4, in sub-clause (6), for the words "six and half years", the words "seven years" shall be substituted.
