Copy with copy of the enclosures forwarded to the nominees concerned. They are requested to take steps immediately for lifting of iodised salt. The progress reports on arrangements made and lifting etc. may be submitted to this Department in addition to all prescribed returns to the undersigned regularly by them without any delay. Their performance will be evaluated both in terms of quantity & quality at the time of allocation of rakes in the next quarter & thereafter regularly. Further the arrival reports alongwith the copy of railway receipt report in support of the lifting of salt quota (allotted rakes) should be reported to Superintendent of Salt, Humma, Ganjam by them under intimation to F.S. & C.W. Department.

After receiving the salt-rakes from the state of Gujarat and Rajasthan, the Salt nominees should ensure supply of iodized salt to the open market for the purpose of sale. He should co-operate with the superintendent of Salt, Humma, Ganjam in lab test of Salt. In case non-iodised salt is supplied, action as deemed proper will be taken against the nominee concerned.
