Sub: State pool allotment of BPL rice for SC & ST Hostel for each month of October & November, 2013.

Sir,

In supersession to this Department letter No.15629 dt.12.09.2013 and No.18478 dt.25.10.2013 on the subject cited above, I am directed to communicate district wise allotment of 5588.535 MT of BPL rice for S.T. & S.C. Hostels, for each month of October & November, 2013 as per the quantity mentioned against each in the annexure enclosed. The scale of entitlement will be limited to 15 kg. per inmate per month @ Re.1/- per kg. uniformly. The entire quantity of this allotment will be provided by the OSCSC Ltd. from the State pool.


2. All other terms and conditions will remain unaltered. This allocation may be distributed only amongst the S.T. & S.C. Hostels as per the list provided by the S.T. & S.C. Development Department on the basis of intake capacity and number of inmates approved by the S.T. & S.C. Development Department.

3. There will be no diversion of rice from other schemes henceforth.

4. Institutions should be given entitlement cards to enable them to draw rice. The officers of concerned Department will certify utilization of stock for bonafide purpose in the card every month.

5. In case, closing stock is available with the institutions, equal quantity will be reduced from the allocation for the next month.
