Hostels, for each month of October & November, 2013 as per the quantity mentioned against each in the annexure enclosed. The scale of entitlement will be limited to 15 kg, per inmate per month @ Re.1/- per kg. uniformly. The entire quantity of this allotment will be provided by the OSCSC Ltd. from the State pool.
