Sub: Allotment of BPL rice for ST & SC Hostels for each month of October & November, 2013 - from out of Central Government allotment.

Sir,

I am directed to communicate district wise allotment of 941.925 MT of BPL rice for S.T. & S.C. Hostels, for each month of October & November, 2013 as per the quantity mentioned against each in the annexure enclosed out of Government of India allocation. The scale of entitlement will be limited to 15 kg. per inmate per month @ Re.1/- per kg. uniformly. This allotment will be lifted from Central pool stocks of FCI / CMR of DCPS as per the lifting plan of the OSCSC Ltd. The rice utilized from own CMR may please be replenished.

The validity period for deposit of cost and lifting of food grains from the months of October & November, 2013 will be up to 45 days & 50 days respectively from the date of issue of Government of India letter which was issued 08.11.2013. The validity period for the subsequent months from December, 2013 to March, 2014 will be as per instant instructions of Government.

2. All other terms and conditions will remain unaltered. This allocation may be distributed only amongst the S.T. & S.C. Hostels as per the list provided by the S.T. & S.C. Development Department on the basis of intake capacity and number of inmates approved by the S.T. & S.C. Development Department. The rice will be lifted by the rice receiving centre-cum-Departmental Storage centre immediately and made physically available to the institutions.

The officer- in charge of RRC-DSC will issue cash memo to the institution and obtained signature.

3. There will be no diversion of rice from other schemes henceforth.

4. Institutions should be given entitlement cards to enable them to draw rice. The officers of concerned Department will certify utilization of stock for bonafide purpose in the card every month.

The institutions will lift their quota from the concerned RRC-cum- DSC. They will not be asked lift rice from FCI / DPC depots. The officer in-charge will issue cash memo to the institution and obtain signature.

5. In case, closing stock is available with the institutions, equal quantity will be reduced from the allocation for the next month. However, full quota of Central pool must be lifted by OSCSC Ltd., and no quantity should be allowed to lapse.
