Last date for receipt of proposals in all respect is **on or before 16.11.2021**. The authority reserves the right to cancel any or the entire tender process without assigning any reason thereof.

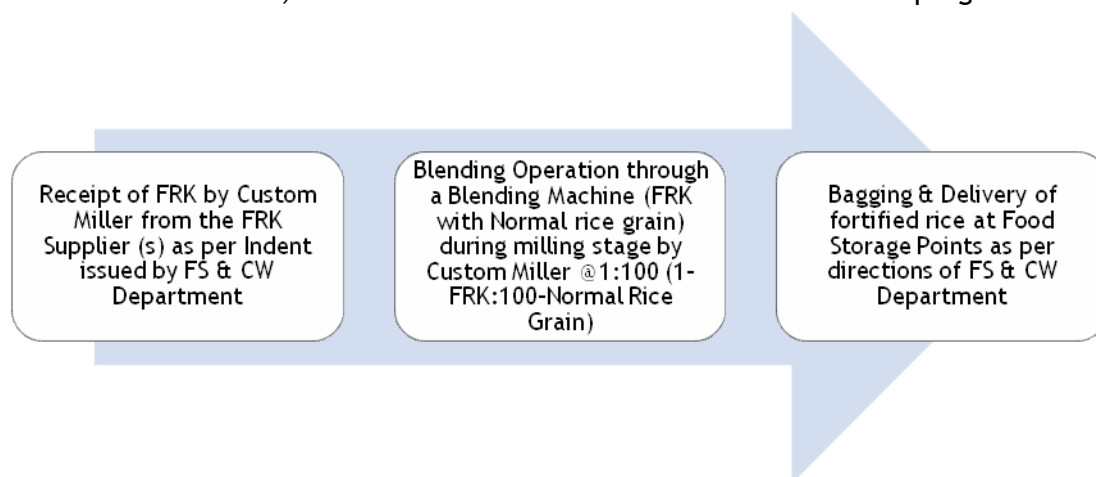
Supply of Fortified Rice Kernels (FRK)

Terms of Reference (ToR)

Through these terms of reference, Food Supplies & Consumer Welfare Department, Government of Odisha intends to procure **FORTIFIED RICE KERNELS (FRKs)** from the registered FRK manufacturing firms for its blending with regular rice to form fortified rice in **seven districts** of Odisha State namely **Malkanagiri, Baragarh, Kalahandi, Sambalpur, Subarnapur, Bolangir and Nuapada**, during the KMS 2021-22.

Fortification of rice is a two-step process; a) procurement of fortified rice kernels and b) its blending with regular rice in a ratio varying between 0.5%-2%. Fortified Rice Kernels (FRKs) are manufactured by combining rice powder and micronutrients, using appropriate extrusion technology. The micronutrient fortified rice kernels closely resemble the sheen, transparency, consistency and flavour of rice. In the given project, to fortify the rice, these fortified rice kernels will be blended with regular rice at a ratio of 1:100, i.e. 1 MT of FRK is mechanically blended with every 100 MTs of rice to get 101 MTs of fortified rice.

Strategy for Rice Fortification: Fortified Rice Kernels (FRK) will be procured by the Odisha State Civil Supplies Corporation Limited (OSCSC) on behalf of the Department of Food Supplies & Consumer Welfare, Government of Odisha. The indented consignment (s) of fortified rice kernels shall be delivered at the designated locations in the above seven districts by the Manufacturer (s) selected and empanelled by Department of Food Supplies & Consumer Welfare, Government of Odisha under rice fortification programme.



Requirements from FRK suppliers:

- 1. Composition of Fortified Rice Kernels:** Each FRK granule to contain - Normal rice powder with micronutrients (i) Iron, (ii) Vitamin B-12 (iii) Folic Acid, as per the proportion prescribed by Government of India.
- 2. Requirement of Fortified Rice Kernels & Timeline for Delivery:** The tentative requirement of Parboiled & Raw Fortified Rice Kernel for the listed Seven districts is **10,800 MT** or more the break-up of which along with expected timeline for its delivery at the district headquarter depots is given as under:

- i. Delivery of 1st Consignment shall start within 7 days of receipt of the Work Order followed by completion of delivery of the indented quantities of FRK within the timeline as fixed by FS&CW Department, mentioned in the indent, from time to time.
 - ii. Every truckload of FRK delivered by the Manufacturer shall carry single Batch Number.
 - iii. Interested bidder shall submit bid taking into consideration one district as a separate unit based on its FRK production & delivery capacity with reference to Annexure-I, Table Serial No-11 & Annexure-II.
 - iv. In case it is found that bidder applied for more than one unit district becomes L1 but the FRK production & delivery capacity doesn't commensurate with the fixed timeline, the tender committee reserves the right to negotiate with the L2 bidder at L1 quoted rate for supply of the total requirement of the unit district, at any ratio as appropriate or for distribution of districts among the selected firms for supply of FRKs, in the interest of public.
 - v. FS & CW Department shall be the final decision making authority on such recommendation from the tender committee.
3. **FRK Delivery Address:** Consignee is the Chief Civil Supplies Officer-cum-District Manager/Civil Supplies Officer-cum-District Manager (CCSO/CSO), Odisha State Civil Supplies Corporation Limited of the above 7 districts. FRK shall be delivered at the district headquarter RRC-cum-DSC as per direction of the CCSO/CSO.
4. **Packaging instructions:** FRK shall be delivered in appropriately labelled **20 Kg woven HDPE bags with an inner LDPE lining**. The packaging material to comply with the specifications given below:

Outer Packaging Material: Woven HPDE Outer bag: 80g Inner Liner Packaging Material: LDPE Liner Thickness: 250 gauge Packaging Size: 20 kg

5. **Marking instructions:** The markings on the bag should mention the following. The draft label shall be shared with Government of Odisha well in advance for approval.

6. **A Batch Number-wise Certificate of Analysis (CoA)** for the produced FRK covering the micronutrient levels and microbiological parameters from an external NABL accredited laboratory should be submitted to Department of Food Supplies & Consumer Welfare, Government of Odisha, Odisha Secretariat, Bhubaneswar, at least 2 (two) weeks in advance of the date of despatch of the FRK to the above districts for future analysis & record. The supplier shall, along with the CoA, also submit a 500-gram sealed sample drawn from the consignment to be supplied against the indent received from the FS&CW Department, for future analysis & record.
7. **Shelf Life of FRK:** The FRK produced should have a shelf life of minimum 12 months from the date of receipt at the delivery locations.
8. **Responsibilities of Fortified Rice Kernels (FRK) Supplier:** The FRK shall be manufactured using extrusion technology which involves dry mixing of rice flour & premix followed by addition of water. This blend is passed through a twin-screw extruder with heating zones, which produces kernels similar in shape and size of rice. These kernels are dried in multilayer dryer and passed through cooling conveyor and packaged.

The FRK manufacturer shall develop and maintain Standard Operating Procedures (SOPs) for production of the kernels for the given composition which includes details on - (i) Process for manufacture of FRK; (ii) Cleaning of plant & equipment; (iii) testing protocols for in-process and finished goods. Details of the SOP and other aspects of information as mentioned below are to be maintained by the vendor for review and submission to FS&CW Department.

- Certificate of Analysis (CoA) for each batch of premix received for production of the FRK;
- Extrusion Temperature
- Dryer Temperature
- Kernel length, width and density
- Cooking quality
- Deviation & Corrective Action Records

9. **Indicative levels of micronutrients and premix:** The indicative levels of micronutrients and premix are below. However, the levels of micronutrients and premix will be as per decisions of the Technical Advisory Committee.

10. Micronutrient premix used in the development of FRK: The micronutrient premix for production of FRK to be procured from an approved supplier with a valid FSSAI license. Micronutrient premix must be delivered to the processor of Fortified Rice Kernels with a complete Certificate of Analysis (CoA) as well as proof of purchase of premix. Micronutrient premix to be stored in a dry, cool & clean place. Storage temperature should not exceed 25°C. The design and development of the premix to achieve the micronutrient requirement in FRK and fortified rice should include necessary overages as detailed out in Table 3 to cater to losses during the production process.

Table 3-Minimum overages for production and storage/cooking losses to be considered for designing the premix for production of FRK.

The micronutrient premix shall contain appropriate food grade material. The premix shall be of vegetarian source. Each consignment of premix shall be accompanied by a CoA from an external NABL accredited laboratory. This CoA shall be filed with the FRK manufacturer and shared with Department of Food Supplies & Consumer Welfare, Government of Odisha on email before each batch of production.

11. Food safety and risk assessment at manufacturing premises: The FRK manufacturer must be registered under Food Safety and Standards Authority of India (FSSAI) and should have a valid license for production of fortified rice kernels. For compliance with food safety standards, the processor must be able to demonstrate by principle and practice the adoption, implementation and recording of:

- a. Good Manufacturing Practice
- b. Hazard Analysis Critical Control Point program
- c. Quality Management System

In this context, a Government of Odisha Officer, shall visit the factory without prior notice during any period when the product is being manufactured to check that the GMP and HACCP systems are in place. The Officer may request to see in the FRK manufacturing factory:

- a. Records (i.e. names of Production and Quality Assurance In charge)
- b. Records of process control parameters such as temperature inside the extruder in all three zones, dryer and cooler. Moisture content in Raw rice flour, Rice flour + Premix, just extruded kernel, Kernel after drying and Kernel before packaging.
- c. Record on FRK testing reports on cooking characteristics, Time & Temperature, Length & width.
- d. Procedures (e.g. cleaning, personnel hygiene, HACCP, sampling and analysis).
- e. Work Instructions (e.g. process instructions, cleaning instructions).
- f. Quality manual for the FRK manufacturing process
- g. Records on Pest control treatment.
- h. Test Report on water analysis

13. Specifications for Potable/Drinking Water: The potable drinking water to comply with IS 10500:1991 standards. The water should be tested at least once in quarter and reports should be kept in the records.

Recommendations: Fortified rice shall comply, in terms of raw materials, composition or manufacture, except when specified otherwise in this contract with the following guidelines or standards:

- i. (5) Rice, (1) Food Grains meant for human consumption, Regulation 5.4.6 Food Grains, Part 5.4 Cereal & Cereal Products Food Safety and Standard Regulations (2011).
- ii. Codex Standard for Rice (CODEX STAN 198-1995).
- iii. Recommended International Code of Practice: General Principles of Food Hygiene CAC/RCP 1-1969 Rev 4 - 2003 including annex "Hazard Analysis and Critical Control Point (HACCP) System and Guidelines for its application".
- iv. General Principles for addition of essential nutrients to foods: CAC/GL 09-1987 (amended 1989, 1991) of the Codex Alimentarius.

14. Eligibility/Prequalification conditions

- a) The firm should be registered in India under Companies Act/ Partnership Firm/ Sole-proprietorship firm or any other registered body having valid registration certificate.
- b) The firm shall have its own manufacturing unit of Fortified Rice Kernels.
- c) The firm shall have valid GST registration issued by concerned authorities.
- d) The FRK manufacturer should possess a valid FSSAI license and comply with plant Hygiene requirements detailed out in FSSAI.
- e) The firm should not have been blacklisted/convicted for any offences or violation of any State or Central act such as essential commodities act etc or any criminal offence under IPC.

15. Documents to be furnished along with application for registration

- a) *Copy of Incorporation certificate/Firm Registration Certificate.*
- b) *The copy of audited balance Sheet and profit/loss account for past three years duly certified by Chartered Accountant (Statutory Auditor) if it is an own processing unit, shall be submitted.*
- c) *Firm shall submit attested copy of the Income Tax returns of last three years or from the establishment of the plant duly certified with a copy of a PAN card attested by authorized signatory.*
- d) *Attested copy of Certificate of registration under GST Act as applicable shall be submitted.*
- e) *The firm shall have to produce the valid license from FSSAI.*

- f) *An affidavit on Rs 100 Non-Judicial stamp paper and attested by the Notary.*
- i. *Not having been prosecuted for violation rules/law under Essential Commodities Act or any such others law or orders there under in any court of law.*
 - ii. *Not having been blacklisted by any organization or Government for non-performance of contractual obligation.*
- g) *In case of partnership firm or Co-operative or Corporate, the Fortified Rice Kernels (FRK) Processing Units, should furnish a copy of the partnership deed or byelaw or memorandum as the case may be. In case of partnership firms, the share holding pattern should be duly certified by the Chartered Accountant along with details of name, age, education and experience of the partners. In case of Co operative/ corporate body copy of letter of authorization to the Chief Executive or the authorized person to participate in the tender process should be furnished.*
- h) *The Fortified Rice Kernels (FRK) Processing Units should furnish letter of authority or power of attorney for having authorized the person to sign the documents on behalf of firm or society or corporate body. Attestation of signature of such authorized signatory from the bank where the firm is having its account is essential.*
- i) *The address proof of the authorized signatory viz Telephone bill/copy of passport/ electricity bill/voter ID proof should be submitted along with the application. The address proof in respect of the firm shall be either certificate of registration or certificate of incorporation issued by the concerned authority.*
- j) *Bank account details of firm along with IFSC code, Branch details, address shall be furnished in the letterhead of the firm.*
- k) *Copy of Experience of running these Services. The Firm shall submit necessary documents in support of current capacity of manufacture & supply of FRKs.*

16. Other Terms & Conditions

- a) *The interested bidder needs to submit **EMD** of Rs 5 (five) lakhs (Rupees five lakhs) for each district applied, in shape of a demand draft drawn in favour of 'Managing Director, Odisha State Civil Supplies Corporation Ltd, Bhubaneswar' payable at Bhubaneswar along with the documents. The EMD of every unsuccessful bid shall be refunded within 15 days of finalisation of the tender process. The Firm shall deposit the EMD of Rs. 5 Lakhs for each applying district separately i.e. If the bidder wishes to apply for two districts for supply of FRK, then two separate demand draft each of Rs. 5 lakhs shall be deposited as EMD separately.*
- b) *The successful bidder upon receipt of communication regarding acceptance of bid by FS&CW Department shall have to submit performance security in shape of Bank Guarantee for an amount equivalent to @5% (Five per cent) of the Work Order value.*
- c) *All the post selection process including terms of DELIVERY of material and payment will be communicated by FS&CW Department to the L1 bidders after accepting the L1 prices.*

- d) *The lowest valid bid once approved by the FS&CW Department will be declared as successful L-1 bidder and the same will be communicated by e-mail to the successful bidder. However, the FS&CW Department reserves the right, without giving any reason, to accept or to reject all or any bid including the lowest bid.*

17. Mode of Submission & Method of Selection of Proposal:

The proposals shall address all the requirements of this expression of interest and must be submitted in the English language. The intending supplier has to submit the 'COMMERCIAL' proposal in one sealed envelope duly super-scribed in bold mark as ***"Expression of Interest for Supply of FORTIFIED RICE KERNELS (FRKs) for the District <Please mention Name of the District>"***. The proposal shall be prepared in indelible ink. It shall contain no interlineations or overwriting, except as necessary to correct errors made by the bidder itself. Any such corrections must be initialled by the person (or persons) who sign (s) the proposals. The proposals shall be submitted through ***Speed Post/Registered Post only*** to ***"The Additional Secretary (NFSA), Food Supplies & Consumer Welfare Department, Loka Seva Bhawan, Sachivalaya Marg, Bhubaneswar-751001, Odisha"*** and no hand receipt of the proposal shall be entertained. FSCW Dept would not be responsible for any delays caused by the registered post/speed-post in this matter. The Least Cost Basis (LCB) method shall be used to select the supplier.

18. Other considerations:

The FRK manufacturer shall also ensure that each consignment of FRK confirms to the specifications prescribed by Government of India.

20. Placement of Work Order & Indents:

The work order shall be placed to the selected firm based on the district-wise total requirement of FRK. However, FS&CW Department will be placing indents for delivery of the FRK in phased manner within a specific timeline based on the blending capacity of the firm, which shall be adhered to. Delivery of 1st Consignment shall start within 7 days of receipt of the Work Order followed by completion of delivery of the indented quantities of FRK within the timeline as fixed by FS&CW Department, mentioned in the indent, from time to time. Any deviation in the matter may attract penalty as deemed appropriate and also may lead to cancellation of the contract agreement.

21. Mode of Payment:

After successful delivery of the FRK consignment (s) at the designated locations, firm shall submit bill in triplicate, raised in favour of ***'Managing Director, Odisha State Civil Supplies Corporation Ltd., C/2 Nayapalli, Bhubaneswar'*** addressed to ***"The***

Additional Secretary (NFSA), Food Supplies & Consumer Welfare Department, Loka Seva Bhawan, Sachivalaya Marg, Bhubaneswar-751001, Odisha” alongwith all supporting documents like e-way bills, Certificate of Analysis (CoA)/FRK test report, Delivery Challan, Transport Challan copy & GST Challan copy etc. or any other documents as may be required during processing of payment. The payment shall be released periodically within 30 days after submission of all necessary documents to this Department. No advance payment shall be released prior to supply of FRK to the listed districts. The payment shall be released on actual quantities of FRK delivered at the districts and any transit loss shall be borne by the successful bidder only.
