No. FSCW-FS1-MISC-0003-2017/ 14362 / dated, Bhubaneswar 21.9.19

In exercise of the powers conferred by the proviso to sub-clause (3) of clause 4 of the Odisha Public Distribution System (Control) Order, 2016, the State Government do hereby modify the order of preference for appointment and for grant of license to dealers as follows:-

Preference for appointment and for grant of license as dealer shall be given to Women Self Help Groups followed by Gram Panchayats or Urban Local Bodies as the case may be, Cooperative Societies, and other Self Help Groups in that order.

It shall come into force on the date of its publication in the Odisha Gazette.
