## GENERAL TERMS AND CONDITIONS

1. The interested Bidders may submit their bid application alongwith an Earnest Money Deposit of Rs.1,000/- by way of **Demand Draft in favour of Secretary, State Consumer Disputes Redressal Commission, Odisha, Cuttack**. The ~~off~~ set price of the vehicle is Rs.18,000/-(Rupees eighteen thousand) only.
2. The quotations received in time will be opened in this Commission. The Bidders or their representative (not more than one) may be present, if they so desire, at time of opening quotations.
3. The auction will be governed by the following conditions:
  - (i) The successful bidder will be required to deposit the balance bid amount and pay all applicable taxes on sale amount including GST at the prevailing rate and will be eligible to deduct earnest money of Rs.1,000/-. The balance bid amount shall be paid latest within one week of opening of bids by way of **Demand Draft in favour of Secretary, State Consumer Disputes Redressal Commission, Odisha, Cuttack**.
