- 7. The tenders received after the stipulated date shall not be taken into consideration and liable for rejection.
- 8. The tender calling authority has the right to cancel or alter quantity of any of above item
- without assigning any reason thereof. 9.The bidder must have valid licence of Manufacturer in Weights & Measures of the concerned state.
- 10. The term of completion of the work 2months from the date of work order.
- 11.All the information as called for in the tender documents should be submitted truly, clearly, legibly, transparently, unambiguously and without the use of abbreviation. It shall be submitted in English.
- 12. All the crucial figures like rates and amount should be quoted in Indian Rupees in figures followed by words in a bracket. There shall be no overwriting in the tender documents and other paper submitted.

Both the covers and other papers/documents of the bidder should be put inside a bigger sealed cover. All the sealed covers shall have bold written with the name of the supplier/ bidder, tender called notice number and the last date for submission
- 16. The tenders or the bids can be sent by Registered post or courier as well, however the authority shall not be responsible for the postal and other delay in receipt of bids.

17. No firm/ company without valid GST registration number and PAN shall be eligible for submitting bids. Firms blacklisted shall also not be eligible to participate in the bid.

18. If the last date for submission of tender/bid turns out to be a holiday, it will automatically be extended to next working day.

19. A bid submitted can't be withdrawn.

20. The sealed tenders and technical bids shall be opened by the technical committee.

21. The documents like EMD, Manufacturing licence, GST registration number etc. shall be verified to ensure that, the bidders have been found to have fulfilled all the prescribed criteria and condition of this tender document other than technical specifications of the product. The decision of the technical committee in this respect shall be final and binding.

22. Financial bid shall be opened only in those cases that have fulfilled the prescribed technical specification. On delivery, the supplies or products shall be inspected to verify the quantity to see whether those are in accordance with the technical specifications (or quality requirements) for which the order was placed. If it turns out to be otherwise the acceptance of delivery shall be refused at the risk and responsibility of the supplier. Further, the articles found damaged shall not be counted as accepted until repaired or replaced to the satisfaction of the authority.

23. All the transit risks shall be the responsibility of the supplier.

24. Failure to supply the order in full within the stipulated period or supply of substandard goods may lead to forfeiture of EMD and blacklisting of the suppliers. If at all the delivery is allowed to be accepted after the due date, Liquidated Damages (LD) @ 0.5% of the total amount of order (excluding taxes) per week or part thereof shall be charged from the bidder, however, that the L.D. shall not exceed 5% of the amount of order.

25. The supplier shall give a "Performance Warranty" for a minimum period of one year of the date of completion of installation. 5% of the amount of the order (excluding taxes) of the contract amount shall be deposited in shape of FDR/Irrevocable Bank Guarantee duly pledged in favour of Tender Calling Authority and shall be returned after the performance warranty period is over. The said amount may be forfeited partially or fully for failure to serve the purpose i.e. leakage, rust in the tanks. The Bank Guarantee should be enforceable and payable at Bhubaneswar. The Performance Security should remain valid for a period of 60 days beyond the date of completion of the obligation of the supplier including warranty obligations.

26. The supplier shall repair or replace at his own cost any component of the prover that may go out of order during warranty period.

27. Payment: 50% of the payment as per the bid amount will be made after arrival of the provers at Directorate campus. Rest amount excluding the performance security will be made after complete installation and calibration of the provers for certification.

28. All the disputes shall be subject to jurisdiction of Civil Court situated at Bhubaneswar.






